### RE: Secured Bullet Loan Proposal

Pursuant to our telephone call, please accept this letter as a Letter of Intent for establishing a Secure Bullet Loan Agreement for \$30M. This Bullet Loan Proposal would involve the Private Lender, GOE Investment Group, and a Multi-Partner Trust Agreement we have created with our Switzerland Asset Management Partner that involves an AA Rated Bank issuing a Standby Letter of Credit SBLC for \$33M to the Private Lender.

The \$30M bullet loan will be used to purchase 2 Vineyards in Fairfield CA, Solano County totaling 51 acres with a total of 36 total planted vineyard vines in 2 separate property sales that have bordering parcels and owned by the same seller, Frank Vezzer who is an established vineyard and winery business owner with award winning wines.

The \$30M Loan will be paid in full in one (1) balloon payment within the time period to be negotiated that includes a fixed \$3M loan fee for a total of \$33M paid to Private Lender. Below is a description of the Secured Bullet Loan proposal that can be negotiated in the Multi-Partner Trust Agreement.

GOEIG has a strategic partnership with a prominent Switzerland Global Asset Management Firm with international investment partners working with their bank and partner banks, including AA and AAA rated international banks based in strategic locations throughout the world including Asia & Europe managing emerging market and global equity investment strategies. The Switzerland Global Asset Management firm fully complies with **FINMA (Swiss Financial Market Supervisory Authority)** to protect investors, provide guarantees in Trust Agreements supported by AAA Rated Bank Standby Letters of Credit.

## Secured Bullet Loan Proposal

Below is a description of the Secured Bullet Loan Proposal that can be negotiated in the Multi-Partner Trust Agreement with GOEIG Asset Management Partner.

**1. GOEIG and Private Equity Lender form a Joint Partnership Loan Agreement and GOEIG Asset Manager creates Trust Agreement functioning as Trustee to Manage Loan Funds**

Secured Real Estate Bullet Loan in a Joint Partnership Loan Agreement for \$30M is secured with GOEIG Asset Management Partner who creates a Multi-Party Trust Agreement that is tied to a AA Rated HSBC Bank of London who issues a cash backed 33M SLBC to Private Lender guaranteeing the Bullet Loan Balloon Payment on or before the due date.

**2. Trustee of the Multi-Partner Trust Agreement**

The Trustee of the Trust Agreement uses the directions given as specifically guided by directions outlined in the Trust Agreement to do the following:

- 1) **Execute the Multi-Partner Trust Agreement**
- 2) **Initiate the AA Rated Bank SBLC to Private Lender**
- 3) **Safeguard the loan assets in the Trust Agreement/Bank Account**
- 4) **Make balloon payment to the Private lender on or before the due date**
- 5) **Make Real Estate property payment pursuant to RE Property Purchase Agreement**
